The 2019 Annual Report of the Kerry Rape and Sexual Abuse Centre ("the Centre") outlines the activities undertaken at the Centre during the year. The Report also includes a summary of the financial affairs of the Centre.

The service to victims of sexual violence, and their families, is increasingly busy. Sincere thanks are extended to the excellent leader of the Centre, manager Vera O'Leary, and the dedicated staff of the Centre who continue to provide a professional and caring service to their clients.

In January it was announced that our Chairperson Carol Anne Coolican had been called to the District Court bench for the Dublin area, unfortunately the Centre this required a relocation and her resignation from the Board. Carol Anne has been a pillar of strength for the board with over 10 years of service and we will miss her sound advice and legal mind. We also said goodbye to Deirdre Kearins and Kate Joyner, and we wish them well in their future endeavors.

#### Centre Manager's Report 2019

2019 has been as busy as previous years. We continue to respond to a growing number of survivors and provide a range of services to meet the needs of survivors, their families, and the community.

The cost of running the services is greater than the funding received. That means we continue to be dependent on the generosity of the public and other donors to be able to respond to the growing demand for the services provided by the Centre. We appreciate all the individuals and groups who continue to raise funds on our behalf.

We were delighted to be once again chosen as one of the beneficiaries of the Ring of Kerry Charity Cycle. This wonderful fundraiser raised much needed funds and generated an awareness of the services provided by the Centre.

We continue to work with Tulsa as our main funder and their support and belief in our work enables us to continue responding to so many survivors.

We were honoured to be invited by the Chief Supt of the Kerry Garda to launch the new Protective Services Unit. This unit delivers a consistent and professional approach to the investigation of sexual crime, human trafficking, child abuse and domestic abuse. The number of reports made to the Garda continue to increase.

Our services extend beyond our therapeutic service. In 2019 we responded to over 1,400 helpline calls and spent 34 days providing Court & Garda accompaniment.

We also continued to deliver The Manuela Programme to many young people in the Kerry region and teachers were trained in the delivery of this worthwhile programme. It is a 12 hour, comprehensive, evidence informed education programme particular to sexual violence prevention with both learning and evaluation as integral parts of the delivery.

I want to acknowledge the hard work, passion, and dedication of our committed and expert staff throughout the year. Their stamina and energy are often tested, but never fails. I also wish to extend sincere thanks to our Chairperson, Ben Slimm and all the Board for their commitment, support and assistance to me and the team. The Board is committed to maintaining the highest standards of good governance and is has been preparing for compliancy with the Charities Governance Code for 2020. We were sad at the departure of some of our Directors who had served for over 11 years but fortunate that we recruited new directors.

Together, board, volunteers, staff & funders, will continue to work to accomplish our key objectives, providing healing and support to the victims of sexual violence, ensuring the rights of those victims in their journey through the justice system and working to eliminate the tolerance of sexual violence in our society.

This was attended by representatives from Community Voluntary sector & the Statutory sector.







# Garda unit set up to help investigate specialised crimes in Kerry



A garda unit has been set up to help investigate specialised crimes in Kerry.

The Garda National Protective Services Bureau provides advice, guidance, and assistance to gardai investigating sexual crimes, child exploitation and domestic abuse intervention. The Kerry Garda Division now becomes one of only ten divisions with the specialised unit. Training for personnel attached to each of the units commenced in the Garda College on the 7th January 2019.

Vera O'Leary of the Kerry Rape Crisis Centre who officially launched the Unit says the it will encourage victims to come forward and report in confidence.

### Consent and Sexual Violence Prevention Education 2019 Year End Report

In 2019, The Kerry Rape and Sexual Abuse Centre (KRSAC) continued its long history of providing sexual violence prevention education to young people, professionals, and community members. KRSAC provided consent and sexual violence prevention education to the community through the Manuela Programme in secondary schools; workshops for adult groups and professionals; a two-hour consent programme and numerous radio interviews and social media posts reaching a diverse population in our community. The education programmes delivered gave 445 youth, 31 teachers and 12 adult community members a safe and open space to develop a greater understanding of consent; examine attitudes, beliefs, and behaviours in regards to sexual violence; and empowered participants to contribute to a culture that supports healthy relationships, respect and equality.

#### The Manuela Programme in Secondary Schools

The main focus of education in 2019 was on delivering the Manuela Programme. The Manuela Programme was developed as a collaborative project between the Rape Crisis Network Ireland, the 16 Rape Crisis Centres in Ireland and the Manuela Riedo Foundation. The Manuela Riedo Foundation initiated this project in memory of Manuela Riedo, a seventeen -year old Swiss student who was sadly raped and murdered in Galway City in 2007.

The Manuela Programme is a six-lesson toolkit for educators that encourages 15-17 year olds to think critically about healthy relationships, boundaries, social media, consent and sexual violence prevention. The programme is very engaging and includes activities, videos and presentations. This innovative pilot project received funding through Tusla and the European Justice Commission to be delivered in secondary schools in Dublin, Wexford, Galway and Kerry from 2018 to 2020. To be selected as one of the four counties in Ireland to participate in this project is a brilliant acknowledgment of KRASC's expertise and over 20 years of dedication to education for young people in the community. In 2019, 12 secondary schools and 424 secondary students and 31 teachers participated in the Manuela Programme and teacher trainings in Kerry.

#### Manuela Programme Aims

Young people who participate in the programme will be able to:

- Demonstrate an enhanced knowledge of what constitutes sexual violence and its impact.
- Identify influences and pressures on young people that can impact mental, emotional, and sexual health.
- Recognize what constitutes a healthy or unhealthy relationship.
- Challenge social norms that are tolerant of sexual violence.

- Develop attitudes that contribute towards equality.
- Make healthier choices in the context of influences in the world around them.
- Be knowledgeable about relevant support services and structures.

An innovative aspect of the project is to train teachers to deliver the programme. The Manuela Project Worker delivers the programme with a teacher from the school and in 2019 a teacher training for the programme was also delivered to teachers in Kerry to allow peer to peer learning. Once teachers are trained, they can deliver the Manuela Programme to students which enables the sustainability and cost effectiveness of the programme. The programme is being evaluated by a team of experienced researchers from NUIG and the finding s will be delivered an event in April 2020 at Dublin Castle.

#### Consent and Sexual Violence Prevention Education in the Community

In addition to the Manuela Programme the KRASC provided consent and sexual violence prevention education to two organizations in the community reaching 21 youth and 12 adults. This was achieved through the delivery of a one-day workshop for adults and a two-hour sexual consent programme for youth.

The workshops defined sexual violence, provided information regarding the law in Ireland and gave participants the opportunity to discuss scenarios that were relevant to their lives or work. All participants received handouts including information explaining sexual consent and a list of phone numbers for support if someone has experienced sexual violence or is supporting a friend or family member who has experienced sexual violence.

#### Community Sexual Consent Programme Aims:

- To raise awareness around sexual violence and to give accurate information
- To discuss the issues around consent, choice and peer pressure
- To promote prevention of sexual crimes by educating people of all ages around roles and responsibilities while equipping and empowering them to respond safely and appropriately

• To inform people of the services offered by Kerry Rape and Sexual Abuse Centre and the benefit of getting help and support in any difficult situation.

#### **Conclusion**

In 2019, KRASC worked to reduce misinformation and confusion around sexual consent and empower individuals to create healthy relationships, safe communities, and reduce the rates of sexual violence in Ireland. Feedback from the 445 youth, 31 teachers and 12 adults who participated in KRASC Consent and Sexual Violence Prevention Programmes was overwhelmingly positive and highlights the importance for education for people of all ages in our community. When students were asked to think about why sexual violence exists they consistently said that there is not enough education in schools and society around this topic and they expressed their appreciation for the opportunity to learn more about negotiating sexual consent, healthy relationships and preventing sexual violence. KRASC appreciates the schools and organisations in Kerry that have collaborated with KRASC in providing sexual violence prevention programmes to secondary students in the last year.

#### Ring of Kerry Charity Cycle







#### **Kerry Rape & Sexual Abuse Centre Statistics 2019**

In 2019 the Centre provided 2,255 appointments and there were over 243 clients availing of face to face counselling, 19 of these Clients were under the age of 18. The Centre saw 160 New Clients in 2019. There were 198 survivors, 176 were female survivors and 22 were male survivors. In 2019, we had 209 female clients and 34 male clients attending the Centre. The Centre had 45 supporters attending, 33 were female and 12 were male. The abuse began as young as 2 years of age. 99% of all perpetrators were male.



The above pie chart illustrates that 86% of the clients seen in 2019 were female and 14% were male.



The above chart illustrates that 81% of clients seen in 2019 were survivors and 19% were supporters.

#### **Accompaniments 2019**

In 2019 the Centre provided 15 days of court accompaniment; this was an invaluable service to the clients who required support throughout the court proceedings. It is vital that victims/survivors are supported during this time. 18 days of Garda accompaniment were provided by the centre to clients. Garda accompaniment is a critical part of our response and it is vital that victims/survivors are responded to in a non-judgemental and supportive manner, giving information, suggesting options but always allowing the victim to decide what course of action to take.


#### **Professional Calls 2019**


